Capitalism is an economic system in which production, trade is privately owned and governed by market economy methods, which in turn follow the princes of supply and demand. The main engine in such a system and supposedly "competition".

Fascism - confesses the idea of a one-nation state. Fascism believes that nations and races are in constant conflict, fascist governments forbid and suppress criticism and opposition against themselves. They are opposed to class conflict.

Fascism is a government that resembles that of Mussolini, which raises the nation and race over the individual, establishes a single-parted system, pushes nationalism, imposes strict economic and social control, violence, censorship

PRINCIPLES OF MAFIOTISMUS - THE NEW TYPE OF STATE GOVERNANCE IN PRIVATE AND PERSONAL INTERESTS

The state is governed by the Prime Minister if the same state is a parliamentary republic that has put in place and directs each state institution - a ministry, a state agency, manages both the executive and the judiciary through appointments that are close to him, and manages the legislative power - the parliament.

The goal will be stealing misappropriation of businesses, properties, and mafia competitors.State agencies will implement the provisions - including the lips of the Prime Minister and his ministers in violation of any laws.

Problems - HIGH LOANS, High Interest, Expensive Food, Expensive Value of Services.Literature and journalism are the two most important educational powers. The Mafia will become the owner of nearly 100 percent of the media - television, radio, newspapers, magazines that control about 90-95 percent of the population.

# IV. PRINCIPLES OF THE FINANCIALLY BANKING RESOURCE-BASED TECHNOLOGICAL MAFIA-DRIVEN MATERIALISM

A. The principles of the Financially banking resource-based technological mafia-driven materialism

Soros adopts the ideology of Carl Popper, who, in 1945, publishes its books on Open Society and its enemies.

Soros created the foundation of the Open Society Foundation in the early 1980s in former socialist countries. This begins in his native Ugaria. It attracts dissident people, the opening of Hungary to the West accelerates the fall of the Burlinska wall.

# VI. PRINCIPLES OF THE PROSECUTOR'S OFFICE AS MAFIA STRUCTURE IN THE MAFIOTISMUS IN EUROPEAN COMMISSION AND BULGARIA

Stretching an umbrella over notary dealers who have drafted notarial deeds that have been stealing property for hundreds of millions of euros. Stretching an umbrella over judiciary judges who commit crimes that rule acts in favor of the executive and the government and harass companies and citizens. Stretching an umbrella over prosecutors commit crimes, cloaking crimes judges. Stretching an umbrella by specialized prosecutors over judges who can not prove their millions where they are. Stretching an umbrella by specialized prosecutors over ministers and prime minister that allow state budget bailouts from private bailiffs who are damaging the budget budget by tens of millions of euros. Stretching the umbrella to the umbrellas and citizens who commit theft and fraud, but who are close to power, to the prime minister, to ministers.

As an example, the Chief Prosecutor of the Republic of Bulgaria Sotir Tsatsarov was elected on the basis of the election of Prime Minister Boyko Borisov, with the support of the United States and the CIA. From 2013 Chief Prosecutor Sotir Tzatsarov has ratified the plan for racketeering, coercion, extortion of citizens and companies, hiding crimes committed by judges, prosecutors, prime ministers.

For all these actions of the Prosecutor's Office and personally the Chief Prosecutor Sotir Tsatsarov was notified the European Commission, the European Union, the European MEPs - almost all, for the financing of EU funds and EU funds. The waste - no reaction.

Ergo - The European Commission, with President Juncker and the European Parliament and the European Commission, supports the Mafia in Bulgaria and the Mafia actions of European statesmen, the Chief Prosecutor, prosecutors, judges, ministers. Europe supports the mafia in Bulgaria, which operates at a state level that does not comply with mandatory directives of the European Commission and the European Union. Europe

The Act of Establishing in 1950 of the Treaty establishing the European Coal and Steel Community between France, Germany, Italy, Luxembourg, Belgium and the Netherlands shows that a cartel process is a monopoly.

Indeed, the most well developed in industrially concerned countries such as France and Germany provide a monopoly for these goods. The next Act, 1957, in Rome, signing the Treaty establishing the European Economic Community and the European Atomic Energy Community is in the same direction.

The subsequent 1959 abolition of customs restrictions in the EEC ensured the monopoly influence of highly industrialized countries.

1962 follows the introduction of the common agricultural policy of the Community.

The 1970s take place alongside the production of the amicable, product-based monopoly of the highly developed countries and the introduction of its own resources and the extension of the budgetary powers of the European Parliament.

Shortly, the lessons learned from the European Funds management - 30-35 percent go to commissions for firms that are intermediaries - and these are the companies of financially banking resource-based technology-matophilized materialism.

The very fact that it is advisable to purchase such equipment, tools, appliances, scientific equipment and others from Germany and France in every purchase of equipment, tools, etc., proves that this is the market for companies in the two countries.

Ie. Real stock funding provides revenue and profits to companies in the two largest countries in Europe - Germany and France.

Their companies also participate in the largest infrastructure projects.

Financing highways usually steals between 30-35 percent minimum. Upon reconstruction of railway lines and railway stations steal at least 30 - 45 percent of the funding.

These commissions go into the pockets of the European mafia.

The very fact that government decides on which programs to apply for what projects and funding.

All this is coordinated between governments and the mafia.

If a private company wants resources to recultivate and rehabilitate private land masses in the next programming period, this can not happen if the private company is not the mafia and is not close to the prime minister. Ie. you only fund projects of mafia and mafia companies.

Ie. the very principle of the creation of the European Union is the profit from the total funding, the commissions from the total project financing and other - regional policies and others.

5). The principle of free movement of money, capital in labor, labor proves the following practice.

Free Moved Capital - used for money laundering and creation of production in countries and armies from the European Union, where labor is the cheapest. One hundred percent of the output is exported, no profit is made in the country concerned, ie. becomes a legitimate European money laundering.

- 6). European societies are cheating on wrong economic indicators that do not take into account the true reality in the community. Indicators such as gross domestic product, foreign direct investment, average wage, growth rates, net exports, imports and exports are real scams and do not take into account real valuesand realities in the community.
- 7). By misrepresentation of economic indicators, a division of European society is created, a distinction is made between the richest and the world's poorest, the middle class is being destroyed, the slavery of 99% of the European population is created in favor of mafiaism and its materialism.
