## I. INTRODUCTION

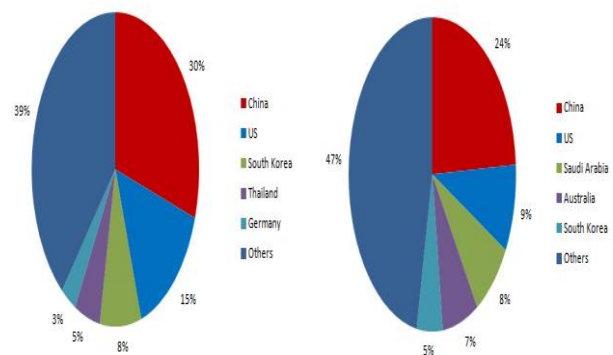

## Importing & Exporting Records among various Countries

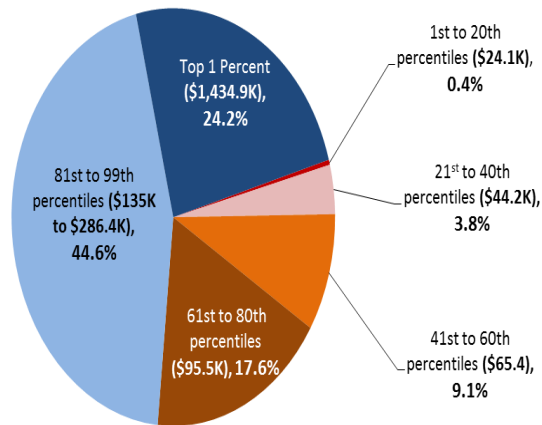

The other process in the tax payment system is to all companies and the industries are paying their taxes regularly, and make people awareness and

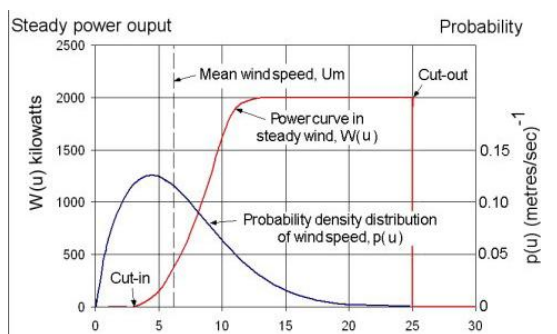

Windmill Power Estimation

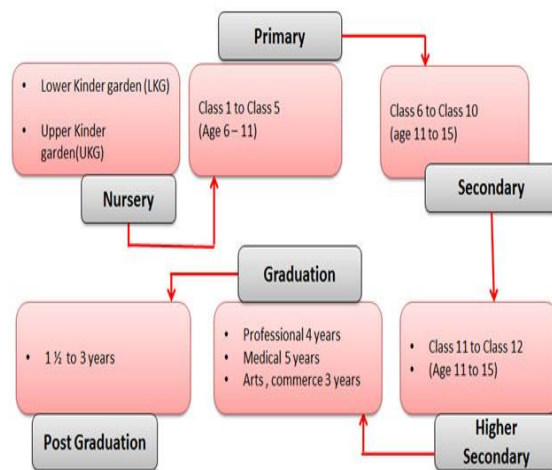
